Approved participants who have purchased and own property which was bought at RM1,000,000 in Malaysia may comply with the basic fixed deposit requirement of RM150,000 on conditions that the property has been fully paid and ownership documents have already been issued. This amount may not be withdrawn until the participant decides to terminate his/her participation in MM2H programme	This amount may not be withdrawn until the participant decides to terminate his/her participation in MM2H programme
Participants must open fixed deposit account at approved panel banks listed on the website <a href="http://www.mm2h.gov.my">http://www.mm2h.gov.my</a>	
All participants and their dependents are required to submit medical reports from any private hospital or registered clinic in Malaysia	
Approved participants and their dependents must possess valid medical insurance coverage that is applicable in Malaysia from any insurance company	
Licensed companies are require to provide the personal bond for their clients who have been approved under the MM2H programme	
Immigration Endorsement Fee <ul style="list-style-type: none"><li>- MM2H visa fee at RM90.00 per person per year</li><li>- Journey Performed Visa at RM500.00 each where applicable (if current visa is not issued from home country)</li><li>- Multiple Entry Visa between RM0.00 to RM50.00 per year depending on applicants citizenship</li></ul>

<p><b>Car purchase</b></p> <ul style="list-style-type: none"><li>- MM2H participants will be exempted from paying excise duty and sales tax when buying new motorcar made or assembled in Malaysia</li><li>- Application for the purchase needs to be forwarded to the Ministry of Finance within one year from the endorsement date of MM2H social visit pass</li></ul>	<p><b>Import Personal Car</b></p> <ul style="list-style-type: none"><li>- For the import of one motorcar from your home country, you will be exempted from paying import duty, excise duty and sales tax</li><li>- Application need to be made by forwarding to the Ministry of Finance within 6 months from the endorsement date of MM2H social visit pass.</li></ul>	<p><b>House Purchase</b></p> <ul style="list-style-type: none"><li>- Foreigners are allowed to purchase any number of residential properties in Malaysia at a minimum price of RM 500,000 per unit subject to the minimum price established for foreigners by the different states</li><li>- Please refer to “List of Minimum Price for Property Purchase under MM2H”</li></ul>
<p><b>Education</b></p> <ul style="list-style-type: none"><li>- Participants are allowed to bring their children, under the age of 21 years old (unmarried) , as their dependents under MM2H programme. For them to continue their tertiary education in Malaysia, they have to terminate their MM2H Social Visit Pass in order to apply for the Student Pass &amp; should be insured throughout their stay under this programme</li></ul>	<p><b>Business</b></p> <ul style="list-style-type: none"><li>- With effect from 1st January 2010, foreigners are allowed to set up 100% foreign ownership Private Limited Companies in Malaysia. To set up a business in Malaysia, you are required to register with Companies Commission of Malaysia (CCM) under the Companies Act 1965.</li></ul>	<p><b>Working Part Time</b></p> <p>It is applicable to those above 50 years old to work as part time lecturers, with a maximum of 20 hours a week. Successful applicants will obtain the endorsement of “Permission to Work” in their passport</p>
<p><b>Tax</b></p> <ul style="list-style-type: none"><li>- This benefit of MM2H is given to pension remitted into Malaysia, by obtaining the endorsement from the Authorities in their country of origin on the total amount of yearly pension received. Do include copy of this statement when applying for tax exemption</li></ul>	<p><b>Domestic Helper / Maid</b></p> <ul style="list-style-type: none"><li>- MM2H applicants can bring along one female maid (aged 21 to 45) from their country to help out at home. The maid visa will be issued on yearly basis subject to successful medical check up.</li></ul>	<p><b>Bringing in Pets</b></p> <p>To confirm that participants’ pet is allowed to be brought into Malaysia, a check has to be made with Veterinary Import Regulations</p>
